DIRECTIONS FOR USE

Outdoor Use

For individual mounds: Sprinkle 2 to 5 level tablespoons of this product around the mound. Do not disturb the mound. Use a disposable scoop (do not use a kitchen utensil). For best results, apply AMDRO® Fire Ant Bait when ants are active. Repeat application as needed.
